2. Technical bid shall contain the following:

- (a) Authorization letter issued by the respective brand manufacturers to sell their products, in the case of Authorized Dealers.
- (b) Earnest Money Deposit (EMD) of Rs.5,000/- (Rupees Five Thousand only) in the form of Demand Draft / Bankers” Cheque of scheduled bank drawn in favour of “**The Administrative Officer, O/o Director, Direct Taxes Regional Training Institute, Nungambakkam, Chennai - 34**”.
- (c) Permanent Account Number (PAN)
- (d) Return of income filed along with a certified copy of the P & L account and Balance Sheet, evidencing that the Gross Turnover for the Financial Year 2013-14 (Asst. Year 2014-15) is over Rupees 25 lakhs.
- (e) Evidence for having supplied Godrej products to Central Government Departments / Public Sector undertaking in the last one year.
- (f) Bidder must have Sales Tax Registration. Evidence should be enclosed.
