- (v) The withdrawal of quotation before the final award of purchase order will result in the forfeiture of the Bid Security amount and the firm / agency will not be considered for bidding in the future.
- (vi) The successful bidder should furnish Performance Guarantee amounting to 5% (Five percent) of the bidding amount in the form of FD Receipt/Bank Guarantee/Demand Draft for a period of six months beyond the period of warranty. The performance guarantee will be returned to the supplier on expiry of the above period.
- (vii) The quotations will be opened by the Local Tender Committee in the presence of authorized representatives of the agencies on 01.12.2016 at 4.00pm.


Bid Security:
