Sealed tenders are invited from prospective suppliers for supply of 35 KVA liquid cooled / 3 phase Diesel Generator Set along with Automatic mechanically functioning Panel and accessories as per CPCB-II norms, to be supplied at the Income tax Office, Karur. 1. technical bid containing technical details of the DG set to be supplied along with quality of wiring, earthing, bed for the DG set, etc. It shall also list out previous experience of the supplier in similar installation:
2. Financial bid – this shall contain the value of the tender.

The quotations must reach the office of the undersigned in a closed cover complete in all respects before 3.00 P.M. of the 17.03.2017. The quotations will be opened on the same day at 5.30 P.M. Participants may present at the time of opening of the bidding either in person or through their authorized representatives.

The bid shall be accompanied by earnest money Deposit (returnable if the bid is not successful) of ₹.10,000/- through Demand Draft favouring the Zonal Accounts Officer, CBDT, Trichy should be enclosed with the Technical bid. No interest will be payable on the EMD. The EMD of the successful bidder will be retained till the completion of the installation.
