TERMS AND CONDITIONS

1. The concerns are required to submit the technical and financial bid in two separate sealed covers clearly super-scribed Technical bid and Financial bid for supply of branded furniture for transit accommodation of DTRTI, Chennai.
2. Late receipt of bids i.e. after the due date and time will not be considered.
3. Authorised representatives of the bidders may participate in the tender opening meeting in case they wish to do so.
4. Rates must be quoted in figures and words INR including all levies and taxes (sales tax, service tax, VAT, etc.) as per the schedule given in the financial bid, composite rates must be quoted for all the items.
5. All pages of the technical/financial bid should be signed by the bidder.
6. Technical details, literature, catalogue, etc. must be attached along with the quotation.
7. Concerns may show the physical sample of the items during the technical bid evaluation process.
8. The bidder should be an individual/ registered firm with trade and taxes/ sales tax/service tax department etc. and should possess PAN, TIN, VAT/sales and service tax as applicable, copies of which may be enclosed.
9. Copies of latest service tax returns for the previous four quarters should be furnished along with the technical bid, if applicable.
10. Bidder should submit turnover details and three out of the last five years copies of income tax returns should be furnished along with the technical bid.
11. Bidders must have preferably supplied to and installed furniture at government/public sector undertakings in the last three years. Details of such supplies should be given in the technical bid.
12. The bidder shall submit to DTRTI a Demand Draft for **Rs.150000/- (Rupees one lakh fifty thousand only)** as Earnest Money Deposit (EMD) along with the technical bid. The DD shall be drawn in favour of DTRTI, Chennai payable at Chennai. Bids without EMD will not be evaluated.
13. The bid will be valid for 90 days from the date of opening of tender. In case of the successful bidder rates quoted shall be valid till the supplies are completed.
14. The final requirement may increase/decrease from the quantity advertised in the tender.

15. The supply and installation should be completed before 28th March 2017.
16. There should be minimum three years warranty on the items supplied and installed.
17. In case the successful bidder fails to deliver the items and complete the installation within the stipulated period, a sum equal to 0.5% of the contract value shall be deducted per week till the actual completion of work subject to maximum of 10% of the value of supply order.
18. No overwriting / cutting will be accepted at the rates quotes in the bids.
19. Payment will be made after supply of furniture items as per the purchase order and guidelines. The delivery will be made as per the supply order and deviation if any may attract penalty. In addition, the EMD shall also be forfeited.
20. DTRTI, Chennai reserves the right to accept or reject any bid and to cancel the bidding process and reject all bids, at any time prior to the award of supply order, without thereby incurring any liability to the affected bidder or any to inform the affected bidder (s) of the grounds for the action of DTRTI, Chennai.
21. All disputes shall be subject to the jurisdiction of the High Court of Madras.
