

Office of the Additional Director of Income Tax (Investigation), Madurai invites quotations for hiring of **Two** operational vehicles, preferably, **WHITE INNOVA**, with effect from 01/05/2018 for the use of Deputy Directors of Income Tax (Investigation), Unit-1 and Unit-2, Madurai, subject to the following conditions:-

- (i). Age of the Vehicles should be less than 2 years;
- (ii). Operator should possess the previous experiences in providing operational vehicles to Govt. Offices and such details are to be provided by the operator;
