TENDER NOTICE

Sealed tenders are invited from prospective suppliers for supply of 35 KVA liquid cooled / 3 phase Diesel Generator Set along with Automatic mechanically functioning Panel and accessories as per CPCB-II norms, to be supplied at the Income tax Office, Namakkal. The details regarding terms and conditions and other documents can be obtained from the Income tax Officer (Admn.), No: 138/3, LMR Shopping Arcade, III Floor, Salem Road, Namakkal-637 001 on or before 30.08.2018 after paying non – refundable tender fee of Rs.1000/- favoring the Zonal Accounts Officer, CBDT, Chennai .

The Tender shall be in two parts –

1. Technical bid containing technical details of the DG set to be supplied along with quality of wiring, earthing, bed for the DG set, etc. It shall also list out previous experience of the supplier in similar installation:
2. Financial bid – this shall contain the value of the tender.

The quotations must reach the office of the undersigned in a closed cover complete in all respects before 3.00 P.M. of the 10.09.2018. The quotations will be opened on the same day at 5.30 P.M. Participants may present at the time of opening of the bidding either in person or through their authorized representatives.


The bid shall be accompanied by earnest money Deposit (returnable if the bid is not successful) of ₹.10,000/- through Demand Draft favoring the Zonal Accounts Officer, CBDT, Chennai, should be enclosed with the Technical bid. No interest will be payable on the EMD. The EMD of the successful bidder will be retained till the completion of the installation.

This office reserves the right to postpone / and / or extend the date of receipt, opening of bids or to withdraw the same without assigning any reason thereof. All the rates must be written both in figures and words. Corrections, if any, are to be made by crossing out, initialing, dating and rewriting. In case of discrepancy between the words and figures, the rates indicated in words shall prevail. All overwriting / cutting, insertions should be authenticated and attested.

Rates, quotations should be signed by the authorized signatory of the firm / agency and should have the current business address of the firm / agency.

The bidder must comply with the rates /quotations, specification and all terms and conditions of the tender. No deviation in the terms and conditions of the tender shall be entertained unless specifically mentioned by the bidder in the rate / quotation and accepted by the department. In case no bidder is satisfying the technical / financial terms of the department, the entire tender process would be cancelled and the decision of this office shall be final.
