4. The bids will be opened on **18.09.2018 at 11.00 A.M** in the Conference Hall, First Floor, No. 44 Williams Road, Cantonment, Trichy -620 001 . The Chief Commissioner of Income Tax, Trichy , reserves the right to cancel or postpone the tender or reject any bid without assigning any reason.

5. The auction will be governed by the following conditions:

- (i) The successful bidder will be required to deposit the balance bid amount after deduction earnest money of Rs.5000/- , latest by 20.09.2018 by way of Demand Draft in favor of 'the Administrative Officer, O/o the Chief Commissioner of Income Tax , Tiruchirappalli.
- (ii) The delivery of the auctioned vehicle will be given only after the successful bidder submits documentary evidence in support of residential status (ration card/voter identity card in the case of individual, and Registration Certificates in case of firms, etc)
