Office of the Assistant Director of Income-tax (Investigation), Trichy invites quotations for hiring of ONE operational vehicle, preferably **WHITE INNOVA(or CRYSTA)**, with effect from 01-08-2019 for the use of Assistant Director of Income-tax(investigator), Trichy, subject to the following conditions:-

- (i) Age of the vehicle should be less than 2 years.
- (ii) Operator should possess the previous experiences in providing operational vehicles to Government offices and such details are to be provided by the operator.
- (iii) The operator should be in a position to offer minimum 30 vehicles as and when requirement arises for specific purposes in this office.
