ORDER

Consequent to the order in Notification No. 5 dated 15.11.2014 of the Principal Chief Commissioner of Income-tax, Tamilnadu in C. No. CHE/COORD/112(2)/JURSDN/2014-15, the designation of the Commissioner of Income-tax (Appeals) - 15 having jurisdiction over persons, assessed in Corporate Range – 6, Non Corporate Range – 15, Non Corporate Range – 18, Non Corporate Range – (Puducherry), Non Corporate Range – (Cuddalore) & Non Corporate Range – (Villupuram) was modified. The Appeals pending before the erstwhile CIT(Appeals)-VI, Chennai are now bifurcated between newly created CIT(Appeals)-15 and CIT (Appeals) – (Puducherry).

- CIT (Appeals)-15 has jurisdiction over persons assessed in Corporate Range – 6
- CIT (Appeals)-15 has jurisdiction over persons assessed in Non Corporate Range – 15
- CIT (Appeals)-15 has jurisdiction over persons assessed in Non Corporate Range – 18
- CIT(Appeals)-Puducherry has jurisdiction over persons assessed in Puducherry
- CIT(Appeals)-Puducherry has jurisdiction over persons assessed in Cuddalore
- CIT(Appeals)-Puducherry has jurisdiction over persons assessed in Villupuram

In order to ascertain the present jurisdiction of the pending appeals, in the case of any given assessee, the details of old ITA Number and the corresponding new ITA Number are given in a tabular form. Appellants are requested to quote the new ITA Number in all communication and contact the new Jurisdictional Appellate Commissioner.
