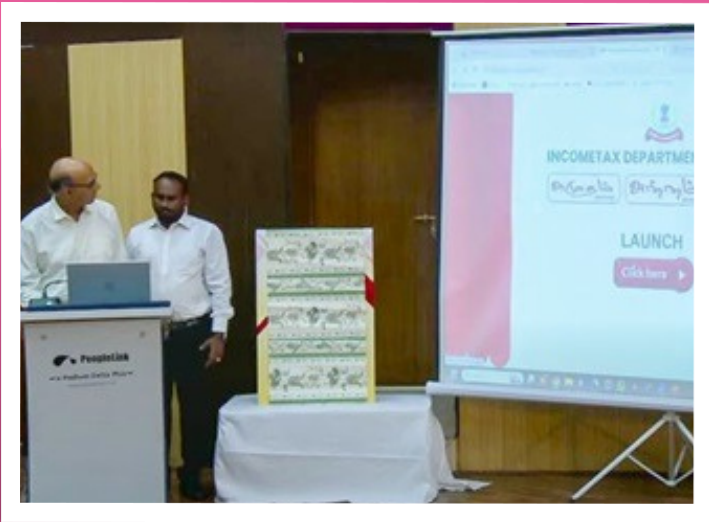
**BABA SAHEB DR.B.R. AMBEDKAR**

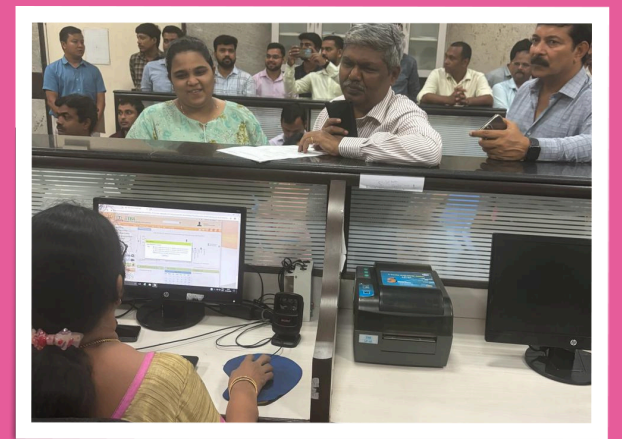
# *Budget Achievement - F.Y 2023-24*
